

Response to Queries Regarding Trading Activity

The Board of Directors (the “Board”) of Creative Technology Ltd (the “Company”) refers to the queries from the Singapore Exchange Securities Trading Limited (“SGX-ST”) on 27 December 2018 regarding the unusual price movements in the Company’s shares on 27 December 2018.

The Company wishes to respond to the queries as follows:

Such information may include events that are potentially material and price-sensitive, such as discussions and negotiations that may lead to joint ventures, mergers, acquisitions or purchase or sale of a significant asset. Question 2: Are you aware of any other possible explanation for the trading? Such information may include public circulation of information by rumours or reports.

Question 3: Can you confirm your compliance with the listing rules and, in particular, Mainboard Rule 703?
