**Swee Hong posts profitable results with 2QFY2018 net earnings of S\$268,000.**

- **2QFY2018 revenue up 25% to S\$17.4 million compared to 2QFY2017 mainly due to increase in the progress of the ER382 project.**
- **2QFY2018 gross profit decreased to S\$1.2 million compared to 2QFY2017 mainly due to reversal in the accrual in 2QFY2017.**
- **2QFY2018 other gains - net decreased to S\$417,000 compared to S\$535,000 in 2QFY2017 mainly due to scheme creditors write-off in 2Q2017.**
- **Net Tangible Assets increased to S\$9.6 million as at 31 December 2017 as compared to S\$8.9 million as at 30 June 2017.**

**Singapore; 14 February 2018** - Swee Hong Ltd (QF6.SI) (“SWEE HONG” or the “Company”) announced its financial results for the second quarter ended 31 December 2017.

**Consolidated Financial Highlights:**

- Revenue for 2QFY2018 was S\$17.4 million compared to S\$13.9 million in 2QFY2017.
- Gross profit for 2QFY2018 was S\$780,000 compared to S\$2.0 million in 2QFY2017.
- Other gains - net for 2QFY2018 was S\$118,000 compared to S\$535,000 in 2QFY2017.
- Net profit for 2QFY2018 was S\$268,000 compared to S\$2.0 million in 2QFY2017.

The Company continued to enjoy increase in revenue mainly due to increase in the progress of the on-going projects, particularly the ER382 project – construction of new road between MacRitchie Viaduct and Adam Flyover.

Revenue increased by S\$3.5 million from S\$13.9 million in 2QFY2017 to S\$17.4 million in 2QFY2018 mainly due to increase in the progress of the ER382 project.

Gross profit decreased by S\$1.2 million from S\$2.0 million in 2Q2017 to S\$780,000 in 2Q2018 mainly due to reversed the accrual in 2Q2017.

Other gains - net decreased by S\$417,000 from S\$535,000 in 2QFY2017 to S\$118,000 in 2QFY2018 mainly due to write-off of pursuant to creditors scheme of arrangement in 2Q2017.

**Continuing Progress**

The Company under the guidance of the new management team is continuing to steer the business forward.

After successfully closing the Scheme Arrangement and improvement in execution capabilities for the projects, the Group has started tendering and is hopeful of being awarded new projects in near future.

The Group has tendered for new projects and is waiting for the results of the tenders as at the date of this press release.

The Company's Non-Executive Director, Mr Anil Agrawal said, "After successfully closing the scheme and with the continuing progress made during the current financial year, the management and Board are working aggressively to secure new projects to strengthen the order book and improve the performance of Company."
