Query

Response

The Company refers to page 23 of AR2020, wherein it was stated in the Corporate Governance Statement that "[t]he Audit and Risk Management Committee was satisfied that the internal audit function is independent, effective and adequately resourced".

The Company further refers to page 22 of AR2020, wherein it was stated in the Corporate Governance Statement that "[t]o enable the Audit and Risk Management Committee to discharge its functions more effectively, for FY2020, the Company had appointed RSM Risk Advisory Pte Ltd, an accounting firm which is not the external auditors, to carry out its internal audit function. The internal audit was carried out in accordance with the Standards for the Professional Practice of Internal Auditing set by The Institute of Internal Auditors, which is a standard set by nationally or internationally recognised professional bodies. The internal audit process includes, *inter alia*, the identification of key risk areas and a consideration of the controls managing such risks."
