Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D011_1/SGD, which was launched on 22 October 2024, under the SDAX CP Facility Programme, had matured on 21 November 2024.

Accordingly, the 170 Tokens under the IL_D011_1/SGD (with an aggregate principal amount of S\$1,700,000) that were issued to Mr Mak Lye Mun (direct and deemed interest) have been fully redeemed by the Company on 21 November 2024.
