Before the transaction, Asdew Acquisitions Pte. Ltd. ("Asdew") has 68,326,974 shares in the Issuer. AOC Acquisitions Pte. Ltd. ("AOC") has 750,000,000 shares in the Issuer. AOC is 60.5% owned by Asdew, a company in which Mr Wang Yu Huei is a majority shareholder and director. As such, he is deemed to have interest in the shares held by Asdew and AOC by virtue of provisions of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore.

On 29 December 2020, AOC resolved to transfer its shareholding of 750,000,000 shares in the Issuer to its shareholders in proportion to their respective shareholdings in AOC. Asdew owns 60.5% of AOC and as such it received 453,750,000 shares in the Issuer. As Mr Wang is a majority shareholder and director of Asdew, he is deemed to have interest in the shares held by Asdew by virtue of provisions of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore.

The deemed shareholding of Mr Wang decreased from 26.71% to 17.04% as AOC no longer has any shares in the Issuer.
