LOGOS China Investments Limited ("LOGOS China") had entered into a share subscription and purchase agreement dated 11 December 2019 ("SSPA") with, amongst other parties, ARA Logistics Venture I Limited ("ARA"), pursuant to which it was agreed, inter alia, that in consideration for the subscription of new shares in LOGOS China, ARA shall, among other things, procure the transfer to LOGOS Units No. 1 Ltd of 108,683,026 units in Cache Logistics Trust and all other units in Cache Logistics Trust acquired or received as payment of fees or otherwise by ARA Trust Management (Cache) Limited or ARA Real Estate Investors V Limited prior to the completion date (collectively, the "Cache REIT Units"), subject to the provisions of the SSPA.

The transfer of the Cache REIT Units was completed on 5 March 2020 and a total of 111,656,105 units in Cache Logistics Trust were transferred to LOGOS Units No. 1 Ltd.

As LOGOS China holds the entire issued share capital of LOGOS Units No. 1 Ltd, it is therefore treated as having an interest in the Cache REIT Units by virtue of the Securities and Futures Act (Chapter 289 of Singapore).
