## ALTERNATIVE ARRANGEMENTS FOR THE ANNUAL GENERAL MEETING OF THE COMPANY TO BE HELD ON 27 MAY 2022

---

### 1. INTRODUCTION

The Board of Directors (the “**Board**”) of Medi Lifestyle Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (“**Order**”) which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment) Order 2021 which extended the application of alternative arrangements in respect of, *inter alia*, general meetings of companies in the relevant order beyond 30 June 2021, until it is revoked or amended by the Ministry of Law; and
- (d) the Joint Statement by the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulation issued on 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020, 1 October 2020 and 4 February 2022) which included a checklist to guide listed and non-listed entities on the conduct of general meetings.

### 2. DATE, TIME AND CONDUCT OF ANNUAL GENERAL MEETING

The Board wishes to inform shareholders of the Company (“**Shareholders**”) that the Company will conduct its Annual General Meeting (“**AGM**”) on, **Friday, 27 May 2022 at 4.30 p.m. (Singapore time)** by way of electronic means pursuant to the Order as part of its efforts to minimise physical interactions and COVID-19 transmission risks.

### 3. NOTICE OF AGM, PROXY FORM AND ANNUAL REPORT

In line with the provisions under the Order, no printed copies of the Notice of AGM, the Proxy Form and the Annual Report will be despatched to Shareholders.

The Notice of AGM, Proxy Form and Annual Report have been made available on the SGX website at the URL <https://www.sgx.com/securities/company-announcements> and on the Company’s website at the URL <https://investor.medi-lifestyle.com/agm.html>.

**4. NO PERSONAL ATTENDANCE AT THE AGM**

Shareholders will **NOT** be able to attend the AGM in person. There will be no live voting or live Q&A at the AGM.

**5. ALTERNATIVE ARRANGEMENTS FOR PARTICIPATION AT THE AGM**

The Company has made the following alternative arrangements for Shareholders to participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings contemporaneously via “live” audio-and-visual webcast (“**Live Webcast**”) or ‘live’ audio-only stream (“**Live Audio Stream**”);
- (b) submitting questions, if any, in advance of the AGM; and/or
- (c) appointing the Chairman of the AGM as proxy to vote on their behalf at the AGM.

Persons holding shares through relevant intermediaries as defined in Section 181 of the Companies Act 1967 (“**Investors**”) (other than CPF/SRS investors) who wish to participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings contemporaneously via Live Webcast/Live Audio Stream;
- (b) submitting questions, if any, in advance of the AGM; and/or
- (c) appointing the Chairman of the AGM as proxy to vote on their behalf at the AGM,
