Menunjuk pada Peraturan Otoritas Jasa Keuangan Nomor 11/POJK.04/2017 tanggal 14 Maret 2017 dan surat dari Bpk. Ir. Bambang Budi Hendarto tertanggal 18 Mei 2017, pada tanggal 10 Mei 2017, Bpk. Ir.
