**PAYMENT OF ACQUISITION FEE BY WAY OF ISSUE OF UNITS
IN ASCENDAS REAL ESTATE INVESTMENT TRUST ("ASCENDAS REIT")**

Capitalised terms used herein, unless otherwise defined, shall have the meanings ascribed to them in the announcement of Ascendas Real Estate Investment Trust dated 4 May 2021 in relation to the Proposed Acquisition of 75% of the total issued share capital of Ascendas Fusion 5 Pte. Ltd.

Further to the announcement dated 30 June 2021 titled "Completion of the Acquisition of 75% of the Total Issued Share Capital of Ascendas Fusion 5 Pte Ltd., Use of Proceeds from the Private Placement and Issuance of Consideration Units", the Board of Directors of Ascendas Funds Management (S) Limited ("**Ascendas-FMS**") wishes to announce that 1,761,424 units in Ascendas Reit (the "**New Units**", and the units in Ascendas Reit, the "**Units**") have been issued today to Ascendas-FMS, in its capacity as Manager of Ascendas Reit. The New Units were for payment of acquisition fee in relation to the acquisition by Ascendas Reit of 75% of the Total Issued Share Capital of Ascendas Fusion 5 Pte. Ltd. on 30 June 2021. These New Units were issued at an issue price of S\$3.0657 per New Unit.

In accordance with the Trust Deed and Appendix 6 (Property Funds) of the Code on Collective Investment Scheme, when Ascendas Reit acquires real estate assets from interested parties, the acquisition fee earned by Ascendas-FMS on such acquisition shall be paid in the form of Units issued by Ascendas Reit at the prevailing market price. These Units should not be sold within one year from their date of issuance. In accordance with established precedence, related fees payable in Units are to be paid 30 days after the completion of the transaction.

The issue price of the New Units was determined based on the volume weighted average traded price for all trades done on Singapore Exchange Securities Trading Limited ("**SGX-ST**") in the ordinary course of trading on the SGX-ST from 15 July 2021 to 29 July 2021 which is 10 business days immediately preceding the date of issue of the New Units to Ascendas-FMS.

Following the above issue of New Units, the total number of Units in Ascendas Reit in issue is 4,194,989,792, of which Ascendas-FMS holds 1,787,403 Units or approximately 0.043% of the total Units in issue.
