### LEAVE OF COURT TO CONVENE SCHEME MEETING

### 1. Introduction

Reference is made to the joint announcement dated 22 June 2016 by the Company and Ideal Homes International Limited in relation to the proposed acquisition of shares in the Company by way of a scheme of arrangement.
