# INCREASE IN ISSUED AND PAID-UP SHARE CAPITAL IN GAS MALAYSIA IEV SDN BHD AND COMMENCEMENT OF CONSTRUCTION PHASE

Unless otherwise defined, capitalised terms used in this announcement shall have the same meaning ascribed to them in the announcements dated 15 October 2012, 15 January 2013, 15 March 2013, 16 May 2013, 24 February 2014, 13 November 2014, 28 November 2014 and 13 July 2015 (the "Announcements").

Further to the Announcements, the board of directors (the "Board" or "Directors") of IEV Holdings Limited (the "Company", and together with its subsidiaries, the "Group") wishes to announce that its wholly-owned subsidiary, IEV Energy Sdn Bhd ("IEV Energy"), has subscribed for 1,082,520 new ordinary shares in the capital of its joint venture company, Gas Malaysia IEV Sdn Bhd ("GMIEV") (the "Subscription"), by way of a cash injection of RM1,082,520 into GMIEV. The cash injection by IEV Energy was funded by the proceeds from the Company's rights issue exercise, which was completed in June 2015.

GMIEV was incorporated in Malaysia on 21 October 2014. It has an authorised share capital of RM10,000,000, comprising 10,000,000 ordinary shares at RM1.00 each. Subsequent to the Subscription and the corresponding subscription for new ordinary shares in the capital of GMIEV by the joint venture partner, Gas Malaysia Berhad, (i) GMIEV has a paid-up share capital of RM5,209,240, comprising 5,209,240 ordinary shares of RM1.00 each; and (ii) each of IEV Energy and Gas Malaysia Berhad holds shareholding interests of 25% and 75% in GMIEV, respectively. The share of the capital contribution by each of IEV Energy and Gas Malaysia Berhad in GMIEV as set out in the JVA is expected to be formalised in stages.

The necessary infrastructure for GMIEV's Compressed Natural Gas distribution system has entered into the construction phase and barring any unforeseen circumstances, the construction is expected to be completed by the end of first quarter in 2016. A groundbreaking ceremony was held on 6 October 2015 in Gebeng, Pahang, Malaysia, to mark the commencement of construction and was witnessed by the local authorities, government agencies and clients. To date, GMIEV has signed Pre-Supply Agreement with five customers with a collective initial gas consumption of approximately 420,000 MMBtu per year.

Save for their respective shareholdings (if any) in the Company, none of the Directors or controlling shareholders of the Company has any interest, direct and indirect, in the Subscription.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company in relation to this announcement.
