INDEPENDENT VALUATIONS

Ascendas Hospitality Fund Management Pte. Ltd., as manager of Ascendas Hospitality Real Estate Investment Trust ("REIT Manager"), and Ascendas Hospitality Trust Management Pte. Ltd., as trustee-manager of Ascendas Hospitality Business Trust (together with REIT Manager, "Managers") refer to:

- 1. the announcements dated 23 December 2015, 23 January 2016, 23 February 2016 and 23 March 2016 informing stapled securityholders of Ascendas Hospitality Trust ("A-HTRUST" and its stapled securityholders, the "Stapled Securityholders") that the Managers were undertaking a strategic review of options for A-HTRUST following receipt of an unsolicited expression of interest ("EOI") relating to the possible acquisition (the "Transaction") of all the stapled securities issued by A-HTRUST (the "Stapled Securities"), and that the Managers were in the process of evaluating proposals from various parties in relation to the Transaction; and
- 2. the announcement of results for the third quarter ended 31 December 2015 dated 28 January 2016 ("3QFY2015/16 Results Announcement"), informing Stapled Securityholders that, to facilitate the Managers' evaluation of the Transaction, the Managers have brought forward the appointment of valuers to conduct independent valuations ("Independent Valuations") on all A-HTRUST portfolio properties typically undertaken in conjunction with the audit of the full year financial results.

The Managers wish to update that the Independent Valuations have been completed and the valuations of the A-HTRUST portfolio properties are set out in the table below:
