UPDATES ON COVID 19 SITUATION (A) OPERATIONS TO CONTINUE DURING THE CIRCUIT BREAKER PERIOD (B) DOMINTORIES HOUSING COMPANY'S FOREIGN WORKERS

Mun Siong Engineering Limited (the "Company") and together with its subsidiaries (the "Group") wishes to provide update on the following:

(A) Company will continue to provide Essential Services from the period 7 April 2020 to 4 May 2020 (inclusive)

We refer to the Ministry of Health (the "MOH") guidelines issued on 3 April 2020 on "Circuit Breaker to minimize further spread of Covid-19". Physical workplaces that cannot be conducted through telecommuting from home will be suspended from 7 April 2020 to 4 May 2020 (inclusive) (the "Circuit Breaker Period"). Essential Services and their related supply chains, as well as entities that form a part of the global supply chain, are exempted from the suspension. Entities providing Essential Services will need to operate with the minimum staff needed on their premises to ensure the continued running of those services and implement safe distancing measures.

The Company has obtained approval from the Ministry of Trade and Industry (the "MTI") on 5 April 2020 that the Company can continue to operate during the circuit breaker period as it is considered to be providing Essential Services. Conditions imposed by MTI on the Company during the circuit breaker period are: (a) operating with minimum staff strength on premises (b) implementing safe distancing measures to reduce physical interactions (for example, implementing shift work and/or split team arrangements, staggering work orders, postponing all group events and reducing the need for and duration of physical interactions) and (c) functions that can be performed remotely must be done at home.

The Company is currently working with our customers to ensure we comply with the above conditions imposed by MTI.

(B) Update on Dormitories Housing Foreign Workers Gazetted as Isolation Areas.

We refer to the Straits Times report, dated 5 April 2020, citing the outbreak of Covid-19 at dormitories located at S11 Dormitory in Punggol (the "Punggol") and Westlite in Toh Guan (the "Westlite").

As at the date of this announcement, the Company has 170 foreign workers directly employed by the Company are housed at Westlite. None of these workers have been infected by the Covid-19 virus at the date of this announcement.

The Ministry of Manpower (the "MOM") and MOH have informed Westlite and Punggol that all residents staying at these two dormitories have to remain inside the dormitory compound for a period

of 28 days with effect from 5 April 2020. MOH and MOM have gazetted Westlite and Punggol as isolation areas. During this period, the residents are not allowed to leave the compound. Management of the Company has been in close communications with the affected workers and will continue to provide the necessary support.

As highlighted in (A), the Company is currently making operation plans with our customers to operate with the minimum staff strength on premises, the Company's foreign workers at Westlite will not impact our operations during the circuit breaker period.

Currently, the Group directly employs more than 800 foreign workers and the Company provides dormitory accommodation for these foreign workers. Any new clusters from other dormitories due to the Covid 19 outbreak, will result in the relevant authorities imposing restrictions and measures that are similar to those at Westlite and Punggol. These restrictions, critical to contain the spread of Covid-19, will cause disruptions to the Group's operations especially during the circuit breaker period.

The Group will continue to provide material updates in relations to the impact of Covid-19 on its operations.
