PAYMENT OF MANAGEMENT FEES BY WAY OF ISSUE OF UNITS IN ASCOTT RESIDENCE TRUST

Ascott Residence Trust Management Limited (the “**Company**”), as manager of Ascott Residence Trust (“**Ascott REIT**”), wishes to announce that a total of 3,202,971 units in Ascott REIT (“**Units**”) have been issued at an issue price of S\$1.2136 per Unit to the Company as partial payment of the base fee and base performance fee (collectively, the “**Management Fees**”) for the period from 1 July 2015 to 30 September 2015 (both dates inclusive).

With the above-mentioned issue of Units, the Company holds an aggregate of 103,541,191 Units, representing 6.69% of the total number of Units in issue of 1,548,735,812.
