## **Secura's subsidiaries, Soverus Pte Ltd and Soverus Consultancy & Services Pte Ltd awarded "A" Grading in Annual Security Agencies Grading Exercise**

**SINGAPORE, 16 December 2016** – Secura Group Limited (新保安集团有限公司) ("**Secura**" or the "**Company**") and together with its subsidiaries, the "**Group**"), one of the leading providers of security products, services and solutions in Singapore, is pleased to announce that its wholly-owned subsidiaries, Soverus Pte Ltd ("**SPL**") and Soverus Consultancy & Services Pte Ltd ("**SCSPL**") have attained the "A" grading (Excellent) under the annual Security Agencies Grading Exercise ("**Grading Exercise**") by the Police Licensing & Regulatory Department.

SPL has attained the "A" grade for six consecutive years from 2012 to 2017. This is SCSPL's first participation in the Grading Exercise.

The Grading Exercise consists of an assessment based on documents submitted by the respective subsidiaries and on-site audits. The audits are focused on three areas, namely, (1) Operations; (2) Training for Operations; and (3) Support for Operations. The Ministry of Manpower's assessment criteria for employment and human resource practices are included in "Support for Operations". SPL and SCSPL are among 228 security agencies assessed in 2016, of which 60 achieved the "A" grade.

The "A" grading attained by both subsidiaries is testament to the Group's commitment to operational excellence, compliance with employment laws and the adoption of progressive employment practices, such as the Progressive Wage Model.
