The New Shares rank pari passu in all respect with the existing shares of the Company. The New Shares are expected to be listed and quoted on Catalist of the Singapore Exchange Securities Trading Limited with effect from 9.00 a.m., Tuesday, 4 July 2017.

Following the allotment and issuance of the New Shares pursuant to Warrants exercise, the total number of issued shares of the Company has increased from 7,214,839,103 to 7,326,139,103.

The total outstanding Warrants remaining after the aforesaid exercise are 2,746,267,598.

The Company has further raised proceeds of S\$779,100 from the exercise of 111,300,000 Warrants. As at the date of this announcement, the total proceeds from the exercise of Warrants is S\$6,509,366.21 ("**Exercise Proceeds**"). The Company will make periodic announcements on the utilisation of the Exercise Proceeds as and when such proceeds are materially disbursed.
