The REIT Manager had, on 9 October 2020, launched a non-renounceable preferential offering (the "Preferential Offering") of 324,639,666 new Units ("New Units") on the basis of 290 New Units for every 1,000 existing Units (fractions of a New Unit to be disregarded) held as at the record date at 5.00 p.m. on Tuesday, 6 October 2020. Under the Preferential Offering, 41,948 New Units were issued to Dr Cheong.

The percentage of unitholdings "immediately before the transaction" is based on 1,364,128,127 Units in issue as at 26 October 2020.

The percentage of unitholdings "immediately after the transaction" is based on 1,688,767,793 Units in issue as at 27 October 2020.
