Delfi receives award as Most Transparent Company (Consumer Staples) at SIAS Investors' Choice Awards 2024

SINGAPORE - 18 September 2024 – SGX Mainboard-listed chocolate confectionery company, Delfi Limited (“**Delfi**”, the “**Company**” or together with its subsidiaries, the “**Group**”) has been named a “Winner” in the Most Transparent Company Award (Consumer Staples) category for the second year running at the SIAS Investors' Choice Awards 2024.

Organised by the Securities Investors Association Singapore (“**SIAS**”), the SIAS Investors' Choice Awards recognises companies that excel in achieving outstanding performance in corporate governance, sustainability practices, and investor relations, along with high standards in transparency and communications throughout the year. SIAS, together with the NUS School of Business, and the Centre for Governance and Sustainability (CGS), assesses all the SGX listed companies based on their Transparency and Disclosure, as part of the STARS framework developed for the Corporate Governance scorecard. In addition, LSEG Stock Reports+ scores are added to tabulate the total score.

Delfi Chief Executive Officer, Mr. John Chuang, said: *“Receiving the Most Transparent Company Award (Consumer Staples) for a second year in a row, is a significant achievement for Delfi and a recognition of the effort we put into our corporate governance practices, and to providing transparent and timely disclosures to the investment community. We are proud of this achievement.”*

ABOUT DELFI LIMITED

Headquartered in Singapore and listed on the SGX-ST since 5 November 2004, Delfi Limited and its subsidiaries (the “Group”) manufactures and/or distributes branded consumer products that are sold in over 17 countries including Indonesia, Singapore, Malaysia, Hong Kong, Australia, Thailand, the Philippines and China.

Formerly called Petra Foods Limited until an official name change that took effect on 9 May 2016, Delfi has an established portfolio of chocolate confectionery brands which are household names in Indonesia and the Philippines. Its flagship brands in Indonesia include “SilverQueen” and “Ceres” that were introduced in the 1950s and “Delfi” in the 1980s. In addition, the Group also distributes a portfolio of well-known agency brands in Indonesia, Malaysia and the Philippines.

The Group was awarded the top spot in the annual Singapore Enterprise 50 Award in 2003 and was recognized as the “Best Newly Listed Singapore Company in 2004” in AsiaMoney’s Best Managed Companies Poll 2004. It was named the “Enterprise of the Year 2004” by the 20th Singapore Business Awards on 30 March 2005 and was named one of “Singapore’s 15 Most Valuable Brands” in November 2005 by IE Singapore.

In addition, Delfi Limited has clinched awards in various categories at the annual Singapore Corporate Awards. The Group won a Silver Award for its inaugural annual report in the “Best Annual Report/ Newly Listed Company” category in 2006. In April 2009, it clinched a Gold Award in the “Best Annual Report/ Companies With \$300 million to Less than \$1 billion in Market Capitalization” category. In May 2010, it won two Silver Awards for “Best Managed Board” and “Best Investor Relations” in the “Companies With \$300 million to Less Than \$1 billion in Market Capitalization” category. In 2015, the Group received a Bronze Award for “Best Managed Board” under the “Companies With S\$1.0 billion and Above in Market Capitalization” category. In 2023, Delfi was named “Winner of the Most Transparent Company Award (Consumer Staples)” at the SIAS Investor Choice Awards 2023 in recognition of its efforts in corporate governance and transparency. In July of 2024, Delfi Limited was included in the inaugural list of the Fortune Southeast Asia 500 in Fortune Magazine, and in August of 2024, was included in the annual list of Forbes Asia Best Under a Billion.

Delfi Limited’s Chief Executive Officer, Mr John Chuang, has also been recognized for his leadership and management of the Group. He was named “Best Chief Executive Officer” at the 2011 Singapore Corporate Awards, “Businessman of the Year” at the 2012 Singapore Business Awards and was one of the recipients of the SG50 Outstanding Chinese Business Pioneers Awards in 2015.
