On 7 April 2014, Hwang-DBS (Malaysia) Berhad ("Hwang-DBS") disposed of all its equity interest in HwangDBS Investment Bank Berhad ("HwangIB"). Hwang Investment Management Berhad ("HwangIm") is a subsidiary of HwangIB. Therefore, each of Temasek Holdings (Private) Limited, DBS Group Holdings Ltd and DBS Bank Ltd. has ceased to have a deemed interest in the 1,900,000 units of the Listed Issuer in which HwangIm has a direct interest.

Temasek Holdings (Private) Limited ("Temasek") does not have any direct interest in the voting units of Croesus Retail Trust (the "Listed Issuer").

Temasek is filing this notification form to report a change in deemed interest from 5.28% to 4.84% of the voting units of the Listed Issuer as a result of the disposal by Hwang DBS (Malaysia) Bhd ("Hwang-DBS") of 100% of its equity interest in HwangDBS Investment Bank Berhad ("HwangIB") ("Transaction"). Hwang Investment Management Berhad ("HwangIm") is a subsidiary of HwangIB. Therefore, each of Temasek, DBS Group Holdings Ltd ("DBSH") and DBS Bank Ltd. ("DBS Bank") has ceased to have an interest in the 1,900,000 voting units of the Listed Issuer in which HwangIB has a direct interest.

The filing of Temasek's deemed interest arises from the deemed interest held by DBSH.

(i) DBS Bank is a wholly owned subsidiary of DBSH and has a direct interest in 4.84% in 4.84% of voting units of the Listed Issuer.

(ii) Temasek has a more than 20% interest in DBSH, an independently managed Temasek portfolio company.
