Meghmani Finechem Limited (MFL), is a subsidiary of Meghmani Organics Limited (MOL). MOL holds 57% of Equity Shares of MFL. The Caustic Chlorine plant with a Caustic manufacturing capacity of 476 Ton Per Day (TPD) and 60 Megawatt (MW) captive power plant is located at GIDC Dahej, Dahej, Bharuch, in South Gujarat.

MFL in line with the company's strategic intent of expanding its chemicals business is considering the proposal to set up **Hydrogen Peroxide** (50%) project of **150 TPD**.

MFL is planning to increase its production capacity of Caustic by **240 TPD** (i.e. 50% increase in present capacity) by using Zero gap Membrane Cell Technology.

To operate the additional capacities of Hydrogen and Caustic MFL is also planning to increase Captive Power plant capacity from 60 MW to 90 MW.

The Plant will be set up at existing manufacturing facility of MFL situated at Plot No. CH1, CH2, GIDC Dahej, Bharuch and will be commissioned in 30 June, 2019. The Cost of the project is estimated at Rs. 400 Crore and it will be funded from Internal Accruals and Term Loan. MFL expects to increase Turnover of Rs. 300 Crores in full Financial Year 2020-21.
