E. Notes to the condensed interim consolidated financial statements

1. Corporate information

Tye Soon Limited (the "Company") is a company incorporated in Singapore. The address of the Company's registered office and principal place of business is 9 Toh Guan Road East #02-01 Singapore 608604.

These condensed interim consolidated financial statements of the Group as at and for the six months ended 30 June 2025 comprise the Company and its subsidiaries (together referred to as the "Group" and individually as "Group entities").

The Group is primarily involved in the import and export, and distribution of automotive parts.

2. Basis of preparation

The condensed interim financial statements for the six months ended 30 June 2025 have been prepared in accordance with Singapore Financial Reporting Standard (International) ("SFRS(I)") 1-34 *Interim Financial Reporting* issued by the Accounting Standards Council Singapore. The condensed interim financial statements do not include all the information required for a complete set of financial statements. However, selected explanatory notes are included to explain events and transactions that are significant to an understanding of the changes in the Group's financial position and performance of the Group since the last annual financial statements for the year ended 31 December 2024.

The accounting policies adopted are consistent with those of the previous financial year which were prepared in accordance with SFRS(I)s, except for the adoption of new and amended standards as set out in Note 2.1.

The condensed interim financial statements are presented in Singapore dollar which is the Company's functional currency.

2.1 New and amended standards adopted by the Group

The Group has applied the following amendment to SFRS(I)s for the annual period beginning on 1 January 2025:

• Lack of Exchangeability (Amendments to SFRS(I) 1-21)

The application of this amendment to standard and interpretations does not have a material effect on the financial statements.

2. Basis of Preparation (cont'd)

2.2 Use of judgements and estimates

In preparing the condensed interim financial statements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

The significant judgements made by management in applying the Group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the consolidated financial statements as at and for the year ended 31 December 2024.

Estimates and underlying assumptions are reviewed on an ongoing basis and are consistent with the Group's risk management where appropriate. Revisions to accounting estimates are recognised prospectively.

Information about judgements, assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities are included in the following notes:

Note 13 – Valuation of inventories Note 14 – Valuation of trade receivables

Measurement of fair values

A number of the Group's accounting policies and disclosures requires the measurement of fair values, for both financial and non-financial assets and liabilities.

The Group has an established control framework with respect to the measurement of fair values. This includes a finance team that has an overall responsibility for all significant fair value measurements, including Level 3 fair values, and reports directly to the Group Financial Controller.

When measuring the fair value of an asset or a liability, the Group uses observable market data as far as possible. Fair values are categorised into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows:

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).

2. Basis of Preparation (cont'd)

2.2. Use of judgements and estimates (cont'd)

Measurement of fair values (cont'd)

If the inputs used to measure the fair value of an asset or a liability fall into different levels of the fair value hierarchy, then the fair value measurement is categorised in its entirety in the same level of the fair value hierarchy as the lowest level of input that is significant to the entire measurement (with Level 3 being the lowest).

The Group recognises transfers between levels of the fair value hierarchy as of the end of the reporting period during which the change has occurred.

2.3 New and amended standards not adopted by the Group

The following new accounting standards and amendments to standards are not yet effective for annual period beginning 1 January 2025 and early adoption is permitted. The Group has not early adopted the new accounting standards in preparing these financial statements:

1. Review

The condensed consolidated statement of financial position of Tye Soon Limited and its subsidiaries as at 30 June 2025 and the related condensed consolidated profit or loss and other comprehensive income, condensed consolidated statement of changes in equity and condensed consolidated statement of cash flows for the six-month period then ended and certain explanatory notes have not been audited or reviewed.

2. Review of performance of the Group

Review of Performance

Group turnover increased by 1.9% to \$130.9 million.

The SGD continued to appreciate against the currencies of two out of three of the Group's main overseas operations during 1H25: the KRW for South Korea and the AUD for Australia. The MYR, the currency of the Group's other main operation in Malaysia, regained some strength against the SGD over the past year. Group turnover would have increased by 4.2% to \$133.8 million had the average exchange rates for the aforementioned and other currencies remained the same against the SGD as in 1H24.

Global demand for automotive parts remained resilient. However, customer sentiment at the importer/wholesaler level, the majority of the Group's global export customer base serviced by the Singapore business, has been increasingly weighed down from 2Q25 by a reordering of the global trading system, as some media would refer to it, arising from the introduction of elevated import tariffs into the US market. Although the Group has not been impacted directly (exports to the US market amounted to 0.2% of turnover in FY24), customer sentiment at the importer/wholesaler level in many export markets has gradually turned more cautious over the past several months resulting in varying degrees of hesitation as the prospect of each country's economy become progressively uncertain. The degree of impact currently felt on each country's economy varies with the individual country's level of dependence on exports to the US.

The degree of competitive intensity affecting the Group has not changed much during 1H25. In markets where competition had intensified over the past two years, efforts made to protect the Group's customer base in the face of such competition have yielded some positivity. Australia is one such market. Although such efforts generally involved providing a higher level of service, often at a higher operating cost, and the introduction of more flexible pricing, customer patronage has improved.

The business in Singapore leverages on global export markets in addition to domestic demand. Although the Group was not materially impacted by the introduction of US import tariffs as exports to the US is small as aforementioned, business sentiment in many countries was affected as a greater level of uncertainty set in. Customer demand remained resilient helping the business to regain some strength from the relative low level achieved in 2H24 to register a 4.6% sequential increase in revenue. Revenue increased by 0.8% in comparison with 1H24.

2. Review of performance of the Group (cont'd)

Review of Performance (cont'd)

Customer demand in South Korea remained firm but the strength of the momentum continues to be affected by weak economic conditions. The economy contracted by 0.2% in Q1 on weak domestic demand before rebounding in Q2 with the help of exports front-loaded ahead of adjustments to US trade tariffs. Further market penetration and market share gains continued to help improve business. Revenue increased by 12.0% in KRW terms but at a lower rate of 4.7% in SGD terms due to the further weakening of the KRW against the SGD in 1H25.

After holding a steady course for the business in Australia in FY24, revenue improved noticeably in 1H25 by 4.9% in AUD terms despite operating within a slower growth environment. Competitive intensity has not dissipated, and efforts made to retain customers resulted in some margin erosion. Rising rental premises-related costs and wage expectations remain challenges slowing the pace of growth. As the AUD weakened further in 1H25, revenue measured in SGD terms declined by 1.0% in comparison with 1H24.

The competitive intensity remained firm in Malaysia but the Group broadly held its ground. Continuing efforts were made to consolidate its market presence but the Group refrained from further intensifying the level of competition in favour of some margin balance. As a result, revenue declined by 2.7% in MYR terms. Measured in SGD, however, revenue increased by 3.4% as the MYR became stronger in comparison with the exchange rate in the corresponding period.

Total margins for the Group decreased by \$0.1 million in 1H25 as the gross margin rate declined.

Operating expenses increased by \$0.2 million with staff and transportation/logistics costs registering the most notable changes. Staff costs decreased by \$0.5 million whilst transportation/logistics costs increased by \$0.4 million. The depreciation of the KRW and AUD against the SGD also played a major part in keeping operating expenses measured in SGD to a very moderate increase of 0.9% over 1H24. Had exchange rates for 1H25 remained the same as in 1H24, staff costs would have remained flat and transportation/logistics costs would have increased by \$0.5 million. Higher staff costs were incurred mainly in South Korea, broadly in line with the continuing growth in the business, but negated by declines elsewhere. The increase in transportation/logistics costs was partially due to the increased usage of sub-contractors and logistics service providers.

Profit from operations before FX (EBIT before FX) decreased by 9.8% from \$5.4 million to \$4.9 million.

Foreign exchange loss amounted to \$0.4 million in 1H25 compared to a loss of \$0.1 million in 1H24.

Profit from operations (EBIT) decreased by 15.0% from \$5.3 million to \$4.5 million.

Total finance cost decreased by \$0.1 million from \$2.1 million to \$2.0 million.

Profit before tax decreased by 20.0% from \$3.1 million to \$2.5 million.

Profit after tax decreased by 9.3% from \$2.4 million to \$2.2 million.

After accounting for foreign currency translation differences of net assets at overseas subsidiaries and branch, total comprehensive income amounted to \$2.6 million.

Right-of-use (ROU) assets decreased by \$0.1 million from \$6.4 million as at 31 December 2024 to \$6.3 million as at 30 June 2025 as a result of additions and depreciation relating to ROU assets.

Group inventory was at 7.4 months as at 30 June 2025 compared to 7.5 months as at 31 December 2024. Inventory levels increased by \$1.2 million from \$125.2 million as at 31 December 2024 to \$126.4 million as at 30 June 2025.

Group receivable level was at 1.6 months as at 30 June 2025 compared to 1.5 months as at 31 December 2024. In absolute terms, trade receivables increased by \$2.3 million from \$32.3 million as at 31 December 2024 to \$34.6 million as at 30 June 2025.

Loans and borrowings, a large portion of which consisted of trade-related bills, increased by \$4.3 million from \$78.9 million as at 31 December 2024 to \$83.2 million as at 30 June 2025. During the same period, Group payable level decreased by \$3.3 million from \$37.1 million as at 31 December 2024 to \$33.8 million as at 30 June 2025.

Cash balances decreased by \$2.1 million from \$14.7 million as at 31 December 2024 to \$12.6 million as at 30 June 2025.

The Group's Current Ratio remained relatively steady at 1.5 times as at 30 June 2025 and 31 December 2024.

The Group's net gearing level increased to 1.11 times as at 30 June 2025 from 1.03 times as at 31 December 2024 as trade payables were paid down to a larger extent than usual as well as a higher drawdown of bank facilities for inventory purchases from suppliers without credit terms.

Cash Flow Statement Review

Cash generated from operations before accounting for changes in working capital amounted to \$7.2 million for the six-month period. After accounting for changes in working capital, cash generated from operating activities amounted to \$8.6 million. Cash flows generated from operating activities after accounting for tax and net interest paid amounted to \$6.9 million. Net cash used in investing activities amounted to \$0.2 million. Net cash used in financing activities amounted to \$8.6 million mainly due to net repayments of short-term bank facilities. Cash balances as at 30 June 2025 amounted to \$12.6 million.

4. A commentary at the date of the announcement of the significant trends and competitive conditions of the industry in which the Group operates and any known factors or events that may affect the Group in the next operating period and the next 12 months.

The competitive intensity experienced by the Group over the past two years will likely continue to be felt. Issues arising from cost-of-living and destocking by smaller competitors remain. Efforts made by the Group have helped to retain customers but margins are expected to remain soft. On a positive note, customers in some markets, including notably Australia, have started to respond more encouragingly, thus helping to regain some revenue momentum.

The uncertainty emanating from a reordering of the global trading system arising from the introduction of elevated import tariffs into the US market will potentially continue to weigh down business sentiment in 2H25 and possibly next year. Recent announcements made on tariff adjustments will take time to analyse and for affected businesses to recalibrate their business plans. The indirect effects on the Group's global export customers will likely dampen the Group's exports from Singapore in the near term.

The Group's reported turnover in SGD continues to be influenced by the strength/weakness of the KRW, AUD and MYR (against the SGD), the currencies of the Group's major overseas operations. Each of these currencies have depreciated significantly against the SGD over past three financial years from FY22 to FY24; the KRW by about 16.3%, the AUD by about 11.5% and the MYR by about 10.3%. Had these currencies remained at rates prevailing at the start of 2022, Group revenues in FY24 would have reached \$278.8 million, an increase of 23.7% over the past three financial years since FY21. It would be notable to point out that the MYR appreciated against the SGD in 1H25, the first time in three years for a reported period. Revenue reported in SGD by the Group will grow in tandem with the appreciation of the aforementioned currencies, if and when that happens.

The Group's focus on slowing down the upward trend in operating costs whilst expanding its activities continues to flatten the upward cost trajectory. Despite the softer outlook on margins, the Group remains on track for another year of profitable growth.
