**FINANCIAL UPDATE FOR THE FIRST QUARTER ENDED 31 MARCH 2016**

---

The Board of Directors of Global Palm Resources Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to announce that, following a preliminary review of the unaudited financial statements for quarter ended 31 March 2016 (“**1Q2016**”), the Group is expected to report a net profit after tax which will be substantially lower than that of the preceding quarter ended 31 March 2015.

The lower net profit after tax is primarily attributable to the decrease in the sales revenue and the average selling price of crude palm oil and palm kernel.

The Group is still in the process of finalizing its unaudited financial results for 1Q2016. Further details of the performance of the Group will be disclosed in its unaudited financial statements announcement for 1Q2016, which is expected to be released on or before 13 May 2016.
