Update to Shareholders

We refer to the Deed Administrators' and Receivers and Managers' previous announcements to shareholders dated 31 August 2023, 1 September 2023 and 4 September 2023 providing information on the Parent DOCA, the Proceedings and the Implementation Agreement.

Capitalised terms have the meaning given in our previous announcement unless otherwise stated.

Update on the Proceedings

On Tuesday, 5 September 2023, there was a hearing before the Honourable Justice Hill in the Supreme Court of Western Australia in relation to the Proceedings.

Justice Hill made orders extending the interim restraints on the defendants until 4pm on Wednesday, 13 September 2023, and preserving the confidentiality of certain documents until further order.

The matter has been listed to consider the confidentiality regime on Thursday 7 September 2023.

The matter has also been listed for 13 September 2023 to hear the Plaintiffs' application to extend the interim restraints until the conclusion of the trial, Austroid's application to consolidate the Proceedings with COR 19 of 2023 and any application for joinder made by any third party.

Programming

- 2. By 4.00pm on 11 September 2023, the Defendants and any third parties seeking to be heard file and serve:
 - (a) any affidavits in respect of orders 2 to 11 of the Originating Process filed 31 August 2023;
 - (b) any application seeking relief in the proceeding in addition to any applications filed on or before today (collectively, the Defendants' and Third Parties' Applications); and
 - (c) an outline of written submissions concerning the making of any injunctions on an interlocutory basis.

- 3. By 4.00pm on 12 September 2023, the Plaintiffs file and serve any responsive material.
- 4. The Plaintiffs' Interlocutory Process and the Defendants' and Third Parties' Applications be listed for hearing at NB 10.00am on 13 September 2023 with 14 September 2023 held in reserve.

Interim restraints

- On the undertaking as to damages of the Plaintiffs, the undertaking as to damages of Mineral 5. Resources Limited and on the Plaintiffs' undertaking that, until 4.00pm on 13 September 2023, or further order, the Plaintiffs will not exercise their contractual right to terminate the Austroid Deed of Company Arrangement or execute any Share Sale Agreement between the Plaintiffs and Mineral Resources Limited, until the trial of these proceedings, or further order.
 - each of the First Defendant (Austroid) and the Second Defendants (Receivers) be (a) restrained from selling, assigning, transferring, encumbering, or otherwise disposing of any legal, beneficial or economic interest in the shares in the Third Defendant (Tawana) held by Alita (Tawana Shares);
 - (b) Austroid be restrained from appointing receivers and/or managers to Tawana or to the Fourth Defendant (Lithco No 2) or from exercising any other right it has as a secured creditor of Tawana or Lithco No 2;
 - the Fifth Defendant (Yihe) be restrained from appointing receivers and/or managers to (c) Lithco No 2 or from exercising any other rights it has as secured creditor of Lithco No 2;

COURT,

- (d) Austroid, the Receivers, Yihe, Tawana and Lithco No 2 each be restrained from selling, assigning, encumbering, or otherwise disposing of any assets of Alita, Tawana and Lithco No 2, save in the ordinary course of business and then only to the extent necessary to discharge Lithco No 2's obligations under an offtake agreement dated 2 March 2022 between Yihe and Lithco No 2;
- each of Tawana and Lithco No 2 be restrained from issuing any new securities; and (e)
- (f) each of Tawana and Lithco No 2 be restrained from entering into any new contracts or variations to contracts other than in the ordinary course of business.
- 6. There be liberty to apply on 2 hours' written notice.


