# COMPLETION OF ACQUISITION OF 2 ALJUNIED AVENUE 1, SINGAPORE 389977, AND USE OF PROCEEDS FROM THE EQUITY FUND RAISING

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of AIMS APAC REIT dated 31 May 2023 titled "Launch of Equity Fund Raising to Raise Gross Proceeds of Approximately S\$100.0 Million" (the "EFR Launch Announcement") and dated 29 August 2025 title "Proposed Acquisition of Framework Building Located At 2 Aljunied Avenue 1, Singapore 389977" (the "Acquisition Announcement").

# 1. Completion of Acquisition of 2 Aljunied Avenue 1, Singapore 389977

Further to the Acquisition Announcement, AIMS APAC REIT Management Limited, in its capacity as manager of AIMS APAC REIT ("**AA REIT**", and the manager of AA REIT, the "**Manager**"), is pleased to announce that AA REIT has completed the acquisition of 2 Aljunied Avenue 1, Singapore 389977 (the "**Property**") today.

#### 2. Use of Proceeds

Further to the EFR Launch Announcement and the announcements dated 31 May 2023, 1 June 2023, 12 June 2023, 14 June 2023, 26 June 2023, 3 July 2023, 6 July 2023, 24 July 2023, 7 May 2025, 30 July 2025 and the Interim Financial Statements disclosure on "Use of proceeds raised from equity fund raising pursuant to Chapter 8 of the Listing Manual" dated 3 November 2023, 7 May 2024, 5 November 2024 and 5 November 2025, the Manager, wishes to announce that, of the gross proceeds of approximately \$\$100.0 million from the Equity Fund Raising, the Manager has utilised \$\$36.2 million (which is equivalent to approximately 36.2% of the gross proceeds of the Equity Fund Raising) to partially fund the acquisition of the Property known as 2 Aljunied Avenue 1, Singapore 389977, as disclosed under paragraph 3 (*Use of Proceeds*) of the announcement of AA REIT dated 1 June 2023 titled "Results of the Private Placement and Pricing of New Units under the Private Placement and the Preferential Offering" (the "Close of Private Placement Announcement"). Such use of proceeds arising from the Equity Fund Raising is in accordance with the Close of Private Placement Announcement.

Further to the deployment of proceeds as described above, the year to date use of proceeds from the Equity Fund Raising are as follows:

- (i) approximately S\$17.9 million (which is equivalent to approximately 17.9% of the gross proceeds of the Equity Fund Raising) has been used for the Identified AEIs. Such use of proceeds arising from the Equity Fund Raising is in accordance with the stated use and is in accordance with the percentage of the gross proceeds of the Equity Fund Raising allocated to such use as set out in the Close of Private Placement Announcement;
- (ii) approximately S\$36.2 million (which is equivalent to approximately 36.2% of the gross proceeds of the Equity Fund Raising) has been used to partially fund the acquisition of the property at 2 Aljunied Avenue 1, Singapore 389977 as described above. Such use of proceeds arising from the Equity Fund Raising is in accordance with the stated use and is in accordance with the percentage of the gross proceeds of the Equity Fund Raising allocated to such use as set out in the Close of Private Placement Announcement;
- (iii) approximately S\$43.5 million (which is equivalent to approximately 43.5% of the gross proceeds of the Equity Fund Raising) has been used to repay existing debts, pending the use of such amount in the manner set out under paragraph 3 (*Use of Proceeds*) of the Close of Private Placement Announcement; and
- (iv) approximately S\$2.4 million (which is equivalent to approximately 2.4% of the gross proceeds of the Equity Fund Raising) has been used to pay the professional and other fees and expenses incurred or to be incurred by AA REIT in connection with the Equity Fund Raising. Such use of proceeds arising from the Equity Fund Raising is in accordance with the stated use and is in accordance with the percentage of the gross proceeds of the Equity Fund Raising allocated to such use as set out in the Close of Private Placement Announcement.

The Manager will make further announcements on the utilisation of the remaining proceeds from the Equity Fund Raising as and when such proceeds are materially utilised.
