Reference is made to the announcement dated 30 July 2019 in relation to the responses to queries from SGXRegco and the Company’s Sponsor, Stamford Corporate Services Pte. Ltd., the Company has on 26 July 2019 and in compliance with paragraph 14 of the 8 May NOC, opened an escrow account with a local bank (the “**New Escrow Account**”). For the reasons set out at the Company’s response to Query 4, as set out in the Company’s announcement dated 30 July 2019, the Company is, at present, unable to place any cash and bank balances in excess of the Group’s operational requirements in the New Escrow Account.

Note A:

Reference is made to:

- (a) the announcement of the Company on 8 May 2019 in relation to the notice of compliance dated 8 May 2019 received by the Company from the Singapore Exchange Securities Trading Limited, and in particular, the funds which have been deposited by the Company into an escrow account held by JLC Advisors LLP ("**JLC**"), a Singapore law firm; and
- (b) the announcements of the Company on 23 May 2019, 25 May 2019, 28 May 2019 and 29 May 2019 in relation to escrow monies deposited with JLC.

The opening balance as at 1 Mar 2020 is not inclusive of the funds which have been deposited with JLC.

The Company is monitoring the situation closely and will take rigorous steps to protect its interests and the recovery of escrow funds of \$33.15 million from JLC (the "**Escrow Funds**"). On 24 February 2020, we note from the media reports that the Managing Director for JLC has since been charged with 12 different charges, 11 of which involving alleged criminal breach of trust as an attorney in relation to the Escrow Funds. However, the whereabouts of the Escrow Funds remain unclear to the Company as at the date of this Announcement. The Company will continue to provide further updates to shareholders on subsequent material developments.
