The Board of Directors of mDR Limited (the “**Company**” and together with its subsidiaries the “**Group**”) wishes to announce that pursuant to Rule 704(17)(b) of the Mainboard Rules of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Group has acquired quoted securities for a total value of approximately S\$8,227,278 for the period 05 November 2024 to 15 November 2024. This is equivalent to 8.5% of the latest audited net tangible assets of the Group.

Pursuant to Rule 704(18)(b), the Group has sold quoted securities of approximately S\$3,800,210 (based on historical cost) for the period 05 November 2024 to 15 November 2024. This is equivalent to 3.9% of the latest audited consolidated net tangible assets of the Group.
