ANNOUNCEMENT PURSUANT TO RULE 704(17)(b) AND RULE 704(18)(b) OF THE LISTING MANUAL OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED

The Board of Directors of mDR Limited (the “**Company**” and together with its subsidiaries the “**Group**”) wishes to announce that pursuant to Rule 704(17)(b) of the Mainboard Rules of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Group has acquired quoted securities for a total value of approximately S\$395,107 for the period 23 June 2023 to 30 June 2023. This is equivalent to 0.3% of the latest audited net tangible assets of the Group.

Pursuant to Rule 704(18)(b), the Group has sold quoted securities of approximately S\$5,673,340 (based on historical cost) for the period 23 June 2023 to 30 June 2023. This is equivalent to 3.8% of the latest audited consolidated net tangible assets of the Group.
