**CIVIL SUIT FILED BY A JOINT VENTURE PARTNER OF AN INDIRECT SUBSIDIARY –
APPEAL**

The board of directors of Clearbridge Health Limited (the "**Company**") refers to the announcements dated 31 May 2020, 23 August 2020, and 8 June 2021 (the "**8 June 2021 Announcement**", and collectively, the "**Announcements**") relating to the abovementioned matter. Unless otherwise defined, capitalised terms in this announcement shall have the same meaning as ascribed to them in the Announcements.

The Group wishes to announce that on 5 August 2021, the Bailiff of the North Jakarta District Court and the Bailiff Central Jakarta District Court, served on TMJ (as Defendant I) and CBMA (as Defendant II), respectively, among others, the official notification of appeal submitted by TMN in Civil Case No. No.227/Pdt.G/2020/PN.JKT.UTR. (the "**Appeal**"). CBMA has been advised by its Indonesian legal counsel that the Appeal was submitted by TMN on 18 June 2021 and until now the case file remains at the Jakarta District Court level and will be delivered to the Jakarta High Court after 19 August 2021. In addition, CBMA has also been advised by its Indonesian legal counsel that if the Appeal succeeds, and the Jakarta High Court finds that the North Jakarta District Court had in fact jurisdiction to hear the Suit, it is likely that the Jakarta High Court will direct the Suit to be returned to and heard in the North Jakarta District Court.

CBMA is currently seeking legal advice on this matter and the Company will update shareholders and potential investors of the Company on any further material development on the matter as and when necessary.

Shareholders and potential investors are reminded to exercise caution when dealing in the securities of the Company and should consult their stockbrokers, bank managers, solicitors, accountants, or other professional advisers if they are in doubt about the actions that they should take.
