CESSATION OF EMPLOYMENT OF CHIEF EXECUTIVE OFFICER

The Board of Directors (the “**Board**”) of Dasin Retail Trust Management Pte. Ltd. (the “**Trustee-Manager**”), as trustee-manager of Dasin Retail Trust, announces that the Trustee-Manager has, on 14 February 2024, given notice of termination with cause to Ms Wang Qiu, the Chief Executive Officer of the Trustee-Manager, of her employment with the Trustee-Manager with effect from 14 February 2024.

Two of the directors of the Trustee-Manager, being Dr Cao Yong and Mr Zhang Zhencheng (together with alternate director Mr Zhang Zhongming), disagreed with the other members of the Board that Ms Wang Qiu’s employment should be terminated.

The Trustee-Manager will make a further announcement on the SGXNET containing the information set out in Appendix 7.4.2 of the Listing Manual of Singapore Exchange Securities Trading Limited after obtaining the input of Ms Wang Qiu on the information to be contained therein.
