Following the allotment and issuance of the New Shares pursuant to Warrants exercise, the total number of issued shares of the Company has increased from 7,168,681,133 to 7,171,788,803.

The Company will make periodic announcements on the utilisation of the Exercise Proceeds as and when such proceeds are materially disbursed.
