## FURTHER UPDATE ON THE RE-OPENING OF F&B OUTLETS IN KEY MARKETS

The board of directors of ST Group Food Industries Holdings Limited (the "**Company**" and together with its subsidiaries the "**Group**") refers to the Company's news release entitled, "ST Group to Selectively Re-Open Majority of F&B Outlets in Three Key Markets" and the announcement entitled, "Update on the re-opening of F&B outlets in key markets" which were released on the SGXNET on 8 May 2020 and 26 May 2020 respectively and wishes to update shareholders that as at the date of this announcement, the Group has successfully re-opened 109 outlets comprising approximately 92.4% of the Group's total network of 118 outlets, an increase of 14 outlets as compared to the number of outlets announced on 26 May 2020.
