Grand Banks' CEO Mark Richards Skippers Australian Yacht To Record Eighth Sydney-Hobart Victory; Congratulated By Board of SGX-Listed Company

SINGAPORE, 30 December 2014 – Singapore Exchange-listed **Grand Banks Yachts Limited** ("Grand Banks") has congratulated its CEO Mark Richards after he skippered his Australian Wild Oats XI team to a record eighth victory in the 70th edition of the Sydney-to-Hobart yacht race.

Mark Richards led the 10-year-old supermaxi, owned by Bob Oatley, to cross the finish line in a time of 2 days, 2 hours and 3 minutes after fighting a strong challenge from the U.S. Comanche team which fielded the most modern supermaxi in the world today.

The eighth win is a record for any skipper since the race was started in 1945, and a major accolade for Mark Richards who was appointed CEO of Grand Banks on 1 August 2014 after the company acquired Palm Beach Motor Yacht, an Australian boat-builder founded and owned by him.

"It is exhilarating that Wild Oats XI has won the iconic 70th Sydney-to-Hobart yacht race for a record eighth time against very strong competition from Comanche of the U.S.A., being the newest and most high tech supermaxi in the world today," said Mark Richards.
