
INVESTMENT IN SUBSIDIARY – VM CAPITAL PTE LTD.

The Board of Directors (the “Board”) of ValueMax Group Limited (the “Company” together with its subsidiaries, the “Group”) is pleased to announce that on 21 January 2020, the Company has increased its investment in VM Capital Pte Ltd (“VMC”), a wholly owned subsidiary of the Company, by way of a cash injection of S\$999,999/-. With this cash injection, the issued and paid up share capital of VMC will be S\$1 million.

The capital injection was funded by the internal resources of the Group and is for the purpose of meeting the working capital requirements of VMC.

The above transaction is not expected to have any material impact on the consolidated net tangible assets and earnings per share of the Group for the financial year ending 31 December 2020.
