**ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE**

The Board of Directors of Marco Polo Marine Ltd (the “**Company**”) wishes to announce that the number of issued ordinary shares of the Company (excluding treasury shares) has increased from 3,557,461,708 ordinary shares to 3,560,779,608 ordinary shares (excluding treasury shares) by way of allotment and issuance of 3,317,900 new ordinary shares pursuant to the exercise of 3,317,900 warrants at the exercise price of S\$0.035 each.

These new shares rank *pari passu* in all respects with the existing shares of the Company and will be listed and quoted on the SGX-ST on 11 January 2023.

Pursuant to the aforesaid exercise of warrants, there are 228,627,630 outstanding warrants each with an exercise price of S\$0.035 expiring at 5 p.m. (Singapore Time) on 27 January 2023.
