Ms Goh was previously with the CapitaLand Group, and her last appointment was Deputy CEO of CapitaLand Mall Trust Management Limited and concurrently Deputy Country Head (Singapore) of CapitaLand Mall Asia Limited.

Ms Goh is a CFA® charterholder and holds a Bachelor of Business Administration (First Class Honours) from the National University of Singapore. She has also completed the Executive Development Program at the University of Chicago Graduate School of Business, USA.
