#### **ATLANTIC NAVIGATION HOLDINGS PROVIDES UPDATE ON SITUATION IN THE MIDDLE EAST**

**02 March 2026** – Atlantic Navigation Holdings (Singapore) Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”), an established integrated offshore marine logistics services group operating predominantly in the Arabian Gulf, provides an update on the development in the Middle East and its impact on the operations of the Group.

The development of direct conflict and retaliation in response experienced by certain countries in the Middle East since 28 February 2026 has been well reported by various media. The Group draws encouragement to report that there has been no significant disruptions or impact to its operations in the Arabian Gulf.

Being a service provider as ship manager as well as in its ship repair and maintenance activities, there has been no reports of casualties or injuries to its employees and crew, or damages to the Group’s facilities and assets under management including the vessels which are being cross-chartered.

The Group has been able to perform resiliently with its compliance to protocols in ensuring safety especially of its staff and crew as well as its adherence to the emergency responses and contingency plans as activated, working in close interaction amongst its various stakeholders including ship-owners, end-charterers and its Group employees both onshore and offshore.

The Group is immensely appreciative of the messages of support and encouragement it has received so far and shall remain vigilant and adaptable to meet the challenges beyond its control moving forward, with the hope of swift resolution to the return of peace and normalcy in due course.
