**MOODY'S ASSIGNS Baa3 ISSUER RATING TO CIT;
(P)Baa3 RATING TO ITS MEDIUM TERM NOTE ("MTN") PROGRAMME**

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT" and the manager, the "**Manager**") wishes to announce that Moody's Investors Service ("**Moody's**") has today assigned a Baa3 rating on:

- (i) CIT,
- (ii) S\$30 million Series 002 Notes (maturing in April 2020),
- (iii) S\$100 million Series 003 Tranche 1 Notes (maturing in November 2018),
- (iv) S\$55 million Series 003 Tranche 2 Notes (maturing in November 2018), and
- (v) S\$130 million Series 004 Notes (maturing in May 2020)

A provisional (P)Baa3¹ senior unsecured rating is also assigned to the S\$500 Million Multicurrency MTN programme established on 2 February 2012 by Cambridge-MTN Pte. Ltd. (the "Issuer").

Cambridge Industrial Trust (“CIT”), publicly listed on the Singapore Exchange Securities Trading Limited since 25 July 2006, is Singapore’s first independent industrial real estate investment trust (“REIT”).

CIT invests in quality income-producing industrial properties and has a diversified portfolio of 51 properties located across Singapore, with a total gross floor area of approximately 8.5 million square feet and a property value of S\$1.4 billion as at 30 September 2015. They range from logistics, warehousing, light industrial, general industrial, car showroom and workshop to business park properties, which are located close to major transportation hubs and key industrial zones island-wide.

The Manager’s objective is to provide Unitholders with a stable and secure income stream through the successful implementation of the following strategies:

- Acquisition of value-enhancing properties;
- Pro-active asset management;
- Divestment of non-core properties; and
- Prudent capital and risk management.

Mitsui also developed the Japan Logistics Fund Inc., a publicly listed REIT in Japan dedicated to investing in distribution facilities.
