
RAFFLES MEDICAL GROUP LTD SCRIP DIVIDEND SCHEME – ISSUE PRICE OF NEW SHARES

(a) The Application of the Scrip Dividend to the Final Dividend

(b) The Books Closure Date

Further to the above, the Directors of the Company wish to inform that for the purposes of the application of the Scrip Dividend Scheme (**the Scheme**) to the FY2015 Dividend, the issue price of the fully paid new ordinary shares of the Company (**New Shares**) to be issued to shareholders who have elected to participate in the Scheme, in lieu of part or all of the cash amount of the FY2015 Dividend, is S\$1.44 for each New Share, based on a 10% discount to the arithmetic average of the daily volume weighted average price of a Share on the Singapore Exchange Securities Trading Limited (**SGX-ST**) for each of the Market Days during the period commencing on the day on which the shares were first quoted Ex-Distribution on the SGX-ST after the announcement of the FY2015 Dividend and ending on 11 May 2016 (being the Books Closure Date for the FY2015 Dividend).

Shareholders not participating in the Scheme will receive the FY2015 Dividend in cash.

The FY2015 Dividend will be paid on or about 28 June 2016.

Notices of Election for the scrip elective with respect to the FY2015 Dividend will be despatched to eligible shareholders on or about 19 May 2016.
