SPACKMAN ENTERTAINMENT GROUP'S FRAME PICTURES SECURES FOUR MAJOR CAMERA EQUIPMENT DEALS FOR KOREAN FILM *GIRL COPS* AND THREE UPCOMING KOREAN DRAMAS: *THE GREATEST DIVORCE*, *THE BEAUTY INSIDE*, *HUNDRED MILLION STARS FROM THE SKY*

- Frame Pictures, a leading movie/drama equipment leasing player in Korea, to supply camera systems and equipment for three upcoming major Korean drama series, *THE GREATEST DIVORCE*, *THE BEAUTY INSIDE* and *HUNDRED MILLION STARS FROM THE SKY* and new Korean movie, *GIRL COPS*
- Frame Pictures continues to secure top quality projects, affirming its status and branding in Korea's camera equipment leasing market

Singapore, 17 August 2018 – Spackman Entertainment Group Limited (“**Spackman Entertainment Group**” or the “**Company**” and together with its subsidiaries, the “**Group**”), one of Korea's leading entertainment production groups founded by financier Charles Spackman, wishes to announce that its wholly-owned subsidiary, Frame Pictures Co., Ltd. (“**Frame Pictures**”), has won contracts to supply camera systems and equipment for three upcoming major Korean drama series, *THE GREATEST DIVORCE*, *THE BEAUTY INSIDE* and *100 MILLION STARS FALLING FROM THE SKY* and the Korean film, *GIRL COPS*.

The total contract value for the four camera equipment deals tentatively stands at KRW 573 million (approximately US\$515,700¹) subject to changes in final filming schedule.

Featuring rising star Wi Ha-jun of the Group's associated company, Spackman Media Group Limited (“**SMGL**”) and directed by Jung Da-won, *GIRL COPS* is an upcoming Korean crime thriller movie to be released in 2019. The film depicts the story of a female policer officer who teams up with her sister-in-law to solve a case of a revenge porn victim committing suicide. The film also headlines Ra Mi-ran of *THE MAYOR* (2017) and *THE LAST PRINCESS* (2016) and Lee Sung-kyung of *DOCTORS* (2016).

Starring top Korean actress Bae Doona of SMGL, *THE GREATEST DIVORCE* is an upcoming romantic comedy drama, scheduled to air in October 2018 on KBS2. Directed by Yoo Hyun-ki, the film is a remake of a popular Japanese drama, *MATRIMONIAL CHAOS*, written by Sakamoto Yuji, who also wrote the original drama of tvN's *MOTHER*.

THE BEAUTY INSIDE is a fantasy drama adaptation of the romance film of the same name, featuring Lee Min-ki of *FOR THE EMPEROR* (2014) and Seo Hyun-jin of *TEMPERATURE OF LOVE* (2017). The love story between a top actress, who changes her appearance whenever a certain supernatural phenomenon occurs, and an airline executive is expected to air in September 2018 on JTBC.

A drama remake of the 2002 Japanese TV series *SORA KARA FURU ICHIOKU NO HOSHI, HUNDRED MILLION STARS FROM THE SKY* is set to be released in September 2018 on tvN. Starring Seo In-guk of *SHOPAHOLIC LOUIS* (2016) and Jung So-min of *BECAUSE THIS IS MY FIRST TIME* (2017), the drama follows the story of two people who cross each other's paths in their daily lives but have a fateful meeting.

Mr. Richard Lee, Interim Chief Executive Officer & Executive Director of Spackman Entertainment Group, said, "Frame Pictures' capability to secure continuous pipeline of top quality projects underscores its reputation and branding in Korea's camera equipment leasing market. We believe that Frame Pictures is well-positioned to capture more of such projects ahead of its planned listing as a combined standalone entity with Novus Mediacorp."

SEGL also owns Novus Mediacorp Co., Ltd. ("**Novus Mediacorp**"), an investor, presenter, and/or ancillary distributor for a total of 76 films (53 Korean and 23 foreign) including *SECRETLY, GREATLY*, which was one of the biggest box office hits of 2013 starring Kim Soo-hyun of *MY LOVE FROM THE STARS* fame, as well as *FRIEND 2: THE GREAT LEGACY*. In 2012, Novus Mediacorp was also the ancillary distributor of *ALL ABOUT MY WIFE*, a top-grossing romantic comedy produced by Zip Cinema. In 2018, *THE OUTLAWS*, co-presented by Novus Mediacorp broke the all-time highest Video On Demand ("**VOD**") sales records in Korea. Our films are theatrically distributed and released in Korea and overseas markets, as well as for subsequent post-theatrical worldwide release in other forms of media, including cable TV, broadcast TV, IPTV, video-on-demand, and home video/DVD, etc. We release all of our motion pictures into wide-theatrical exhibition initially in Korea, and then in overseas and ancillary markets.

We also operate a café-lounge called Upper West, in the Gangnam district of Seoul and own a professional photography studio, noon pictures Co., Ltd..

The Company holds an effective shareholding interest of 41.28% in Spackman Media Group Limited (“**SMGL**”). SMGL, a company incorporated in Hong Kong, together with its subsidiaries, is collectively one of the largest entertainment talent agencies in Korea in terms of the number of artists under management, including some of the top names in the Korean entertainment industry. SMGL operates its talent management business through renowned agencies such as MS Team Entertainment Co., Ltd., UAA & Co Inc., Fiftyone K Inc., SBD Entertainment Inc., and Kook Entertainment Co., Ltd. Through these full-service talent agencies in Korea, SMGL represents and guides the professional careers of a leading roster of award-winning actors/actresses in the practice areas of motion pictures, television, commercial endorsements, and branded entertainment. SMGL leverages its unparalleled portfolio of artists as a platform to develop, produce, finance and own the highest quality of entertainment content projects, including theatrical motion pictures, variety shows, and TV dramas. This platform also creates and derives opportunities for SMGL to make strategic investments in development stage businesses that can collaborate with SMGL artists. SMGL is an associated company of the Company.

The Group owns a 100% equity interest in Frame Pictures Co., Ltd. (“**Frame Pictures**”). Frame Pictures is a leader in the movie/drama equipment leasing business in Korea. Established in 2014, Frame Pictures has worked with over 25 top directors and provided the camera and lighting equipment for some of Korea’s most notable drama and movie projects including the upcoming Korean film *GIRL COPS* (2018) featuring rising star Wi Ha-jun of SMGL and *THE GREATEST DIVORCE* (2018) starring Bae Doona of SMGL. In 2018, Frame Pictures has also won contracts to supply equipment to *THE BEAUTY INSIDE* (2018), *HUNDRED MILLION STARS FROM THE SKY* (2018), *LOVELY HORRIBLY* (2018), *THE GUEST* (2018), historical Korean movie *MALMOI, SUITS* (2018) featuring Park Hyung-sik of SMGL, *MISTRESS* (2018), *LIFE* (2018), *LIVE* (2018) starring Lee Kwang-soo of *RUNNING MAN*, *MY MISTER* (2018) and Netflix’s first Korean original production *LOVE ALARM* (2018). Frame Pictures and Novus Mediacorp are currently seeking to list on the Singapore Stock Exchange.

The Company owns a 100% equity interest in Take Pictures Pte. Ltd. (“**Take Pictures**”) which owns a strong lineup of 10 film projects including the co-production with Zip Cinema for *THE PRIESTS 2*.

The Company owns a 100% equity interest in Constellation Agency Pte. Ltd. ("**Constellation Agency**"). Constellation Agency, which owns The P Factory Co., Ltd. ("**The P Factory**") and Platform Media Group Co., Ltd. ("**PMG**"), is primarily involved in the business of overseas agency for Korean artists venturing into the overseas market. The P Factory is an innovative marketing solutions provider specializing in event and branded content production. PMG is a talent management agency which represents and manages the careers of major artists in film, television, commercial endorsements, and branded entertainment.

On 7 May 2018, the Company announced that it would spin-off Novus Mediacorp and Frame Pictures into a combined entity to seek listing on the Catalist Board of the Singapore Exchange Securities Trading Limited to exploit the growing post-theatrical and camera equipment leasing markets.
