ALIBABA PICTURES PURCHASES DISTRIBUTION RIGHTS FOR SPACKMAN ENTERTAINMENT GROUP'S SUBSIDIARY NOVUS MEDIACORP'S FILM, *LIFE RISKING ROMANCE*, IN CHINA

• Alibaba Pictures' distribution rights cover both movie theatres and online platforms in China

**Singapore, 25 July 2016** – Spackman Entertainment Group Limited ("**Spackman Entertainment Group**" or the "**Company**" and together with its subsidiaries, the "**Group**"), announced today that Alibaba Pictures Group Limited ("**Alibaba Pictures**") has purchased the rights to distribute the Group's subsidiary Novus Mediacorp Co., Ltd.'s ("**Novus Mediacorp**") film *LIFE RISKING ROMANCE* in movie theatres and online platforms in China.

LIFE RISKING ROMANCE, a romance thriller starring Ha Ji-won, Chun Jung-myung and Chen Bolin, is presented and co-produced by the Company's majority- owned subsidiary Novus Mediacorp and is set to be released in Korea in the fourth quarter of 2016.

Mr. Charles Spackman, Executive Chairman of Spackman Entertainment Group, said, "The partnership with Alibaba Pictures to distribute our film allows us to make headway in China and reach a wider audience. Previously, our films were mostly limited to theatrical releases, but leveraging an integrated platform combining both traditional theatres and the Internet will provide more exposure for the Group's film. The rise of online and mobile platforms in China will benefit our Group, and we plan to focus our efforts in delivering top quality Korean content to the Chinese market through these traditional and new channels."

*LIFE RISKING ROMANCE* is co-produced by Novus Mediacorp and B.A. Entertainment Co., Ltd., and is directed by Song Min-Kyu, the producer of the 2011 war film *MY WAY*.

The aforementioned sale of distribution rights to Alibaba Pictures is not expected to have a material financial impact on the net tangible assets per share and earnings per share of the Group for the current financial year ending 31 December 2016.

None of the directors or controlling shareholders of the Company has any interest, direct or indirect, in the above matter other than through their shareholding interests in the Company.

("**Novus Mediacorp**"), an investor, presenter, and/or ancillary distributor for a total of 55 films (36 Korean and 19 foreign) including *SECRETLY, GREATLY*, which was one of the biggest box office hits of 2013 starring Kim Soo-hyun of *MY LOVE FROM THE STARS* fame, as well as *FRIEND 2: THE GREAT LEGACY*. In 2012, Novus Mediacorp was also the ancillary distributor of *ALL ABOUT MY WIFE*, a top-grossing romantic comedy produced by Zip Cinema. Our films are theatrically distributed and released in Korea and overseas markets, as well as for subsequent post-theatrical worldwide release in other forms of media, including cable TV, broadcast TV, IPTV, video-on-demand, and home video/DVD, etc. We release all of our motion pictures into wide-theatrical exhibition initially in Korea, and then in overseas and ancillary markets.

We also operate a café-lounge called Upper West, in the Gangnam district of Seoul and own a professional photography studio, noon pictures Co., Ltd..

The Group is a strategic shareholder of Spackman Media Group Limited ("**SMGL**"). SMGL, a company incorporated in Hong Kong, together with its subsidiaries, collectively is the leading talent agency and entertainment content production company in Korea, managing over 50 artistes including some of the top names in the Korean entertainment industry. SMGL operates the talent management business through renowned agencies such as MSTeam Entertainment Co., Ltd., Fiftyone K Inc., SBD Entertainment Inc., UL Entertainment Co., Ltd., and Kook Entertainment Co., Ltd.

On 30 December 2015, the Group announced a share swap agreement for the sale of its equity interest in its associated company, SMGPL, in consideration for 7,500,000 ordinary shares in the capital of Spackman Media Group Limited. On 16 May 2016, the Group announced the completion of the share swap.
