

SPACKMAN ENTERTAINMENT GROUP'S SUBSIDIARY NOVUS MEDIACORP'S *LIFE RISKING ROMANCE* TO BE SCREENED AT SHANGHAI FILM FESTIVAL

- *Film to be released in Korean theatres in Autumn 2016 and in China in November 2016*

Singapore, 10 June 2016 – Spackman Entertainment Group Limited (“**Spackman Entertainment Group**” or the “**Company**” and together with its subsidiaries, the “**Group**”), announced today that its movie *LIFE RISKING ROMANCE* will be screened at the 19th Shanghai International Film Festival (“**SIFF**”), which is set to run from 11 to 19 June 2016. Along with the Tokyo International Film Festival, the SIFF is considered an A-category international film festival. The film is presented and co-produced by the Company’s 51%-owned subsidiary Novus Mediacorp Co., Ltd. (“**Novus Mediacorp**”) and is expected to be released in Korea in autumn (September through October) 2016 and in China in November 2016.

LIFE RISKING ROMANCE follows the story of Jane, a mystery novel writer (Ha Ji-won), her best friend Rokhwan (Chun Jung-myung), a police officer, and a mysterious, but charming neighbour named Jason (Chen Bolin). The three get intertwined in a complicated relationship amidst investigations into the serial murders happening in town.

The romance thriller stars one of Korea’s top actresses Ha Ji-won, who is best known for her lead roles in television dramas, *EMPRESS KI* (2013/14), *SECRET GARDEN* (2010), and *HWANG JINI* (2006). Ha has also starred in several movies including the 2009 box office hit *HAEUNDAE*, and has won numerous acting and popularity awards throughout her career. Also starring in the film is Korean actor Chun Jung-myung who is best known for his lead roles in the 2015 drama series *HEART TO HEART* and *RESET* (2014). The film also features popular Taiwanese actor Chen Bolin, who is famous for his acting roles in many Chinese films and television dramas including *IN TIME WITH YOU* (2011). He was also the lead actor for *20 ONCE AGAIN* (2015), the Chinese remake of Korean movie *MISS GRANNY*.

LIFE RISKING ROMANCE is co-produced by Novus Mediacorp and B.A. Entertainment Co., Ltd., and is directed by Song Min-Kyu, who is the producer of the 2011 war film *MY WAY*.

Spackman Entertainment Group Limited (“**SEGL**”), and together with its subsidiaries, (the “**Group**”) is a leading entertainment production company that is primarily engaged in the independent development, production, presentation, and financing of theatrical motion pictures in Korea. In addition to our film business, we also make investments into entertainment companies and film funds that can financially and strategically complement our existing core operations. SEGL is listed on the Catalist of the Singapore Exchange Securities Trading Limited under the ticker 40E.

SEGL's Zip Cinema Co., Ltd. (“**Zip Cinema**”) is one of the most recognised film production labels in Korea and has originated and produced some of Korea's most commercially successful theatrical films, consecutively producing 7 profitable movies since 2009 representing an industry leading track record. Recent theatrical releases of Zip Cinema's motion pictures include some of Korea's highest grossing and award-winning films such as *THE PRIESTS* (2015), *COLD EYES* (2013), and *ALL ABOUT MY WIFE* (2012).

SEGL also owns Novus Mediacorp Co., Ltd. (“**Novus Mediacorp**”), an investor, presenter, and/or ancillary distributor for a total of 55 films (36 Korean and 19 foreign) including *SECRETLY, GREATLY*, which was one of the biggest box office hits of 2013 starring Kim Soo-hyun of *MY LOVE FROM THE STARS* fame, as well as *FRIEND 2: THE GREAT LEGACY*. In 2012, Novus Mediacorp was also the ancillary distributor of *ALL ABOUT MY WIFE*, a top-grossing romantic comedy produced by Zip Cinema.

Our films are theatrically distributed and released in Korea and overseas markets, as well as for subsequent post-theatrical worldwide release in other forms of media, including cable TV, broadcast TV, IPTV, video-on-demand, and home video/DVD, etc. We release all of our motion pictures into wide-theatrical exhibition initially in Korea, and then in overseas and ancillary markets.

We also operate a café-lounge called Upper West, in the Gangnam district of Seoul and own a professional photography studio, noon pictures Co., Ltd..

The Group is a strategic shareholder of Spackman Media Group Limited (“**SMGL**”). SMGL, a company incorporated in Hong Kong, together with its subsidiaries, is the leading talent agency and entertainment content production company in Korea, collectively managing 50 artistes including some of the top names in the Korean entertainment industry. SMGL operates the talent management business through renowned agencies such as MStEam Entertainment Co., Ltd., SBD Entertainment Inc., UL Entertainment Co., Ltd., and Kook Entertainment Co., Ltd. SMGL also owns Breakfastfilm and Delmedia through its wholly owned subsidiary Spackman Media Group Pte. Ltd (“**SMGPL**”).

On 30 December 2015, the Group announced a share swap agreement for the sale of its equity interest in its associated company, SMGPL, in consideration for 7,500,000 ordinary shares in the capital of Spackman Media Group Limited. On 16 May 2016, the Group announced the completion of the share swap.

On 19 April 2016, SEGL announced the proposed restructuring of its loss-making assets in connection with the Company's entire equity interest in its indirect wholly-owned subsidiary, Opus Pictures Limited Liability Company, and indirect 51.50% subsidiary, UAA Korea Co., Ltd.
