



SGX-ST Announcement

S\$50 MILLION REVOLVING CREDIT FACILITY AND RULE 704(31) DISCLOSURE

YTL Starhill Global REIT Management Limited as manager of Starhill Global Real Estate Investment Trust ("**Starhill Global REIT**", and the manager of Starhill Global REIT, the "**Manager**") is pleased to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of Starhill Global REIT) (the "**Starhill Global REIT Trustee**") has today entered into a facility agreement (the "**Facility Agreement**") with DBS Bank Ltd., as lender (the "**Lender**") for a five year unsecured sustainability-linked multicurrency revolving credit facility of S\$50 million (the "**Facility**"), which will replace its existing revolving credit facility with the Lender of the same amount expiring in June 2024. The Facility is the first sustainability-linked facility granted to Starhill Global REIT and will be available for drawing from January 2024. The Facility will be used to finance its general corporate funding requirements including capital expenditure to attain green certification for Starhill Global REIT's portfolio of properties. The above transaction is not expected to have a material impact on the gearing of Starhill Global REIT.

Rule 704(31) Disclosure

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Manager wishes to announce that under the terms of the Facility Agreement, the Lender has the right to require the Starhill Global REIT Trustee to repay all amounts owing under the Facility Agreement in the event (each, a "**Change of Control Event**") that:

- (a) the Manager or any of its Affiliates (as defined in the Facility Agreement) ceases to be the manager of Starhill Global REIT and a replacement manager reasonably acceptable to the Lender is not appointed on or prior to the date of such cessation; or
- (b) YTL Corporation Berhad (or such other entity as may be acceptable to the Lender) ceases at any time to own (directly and/or indirectly) at least 51% of the issued share capital of the manager of Starhill Global REIT.

YTL Corporation Berhad currently owns indirectly all the issued share capital of the Manager and a Change of Control Event has not occurred.

Assuming that a Change of Control Event occurs when the full amount of Starhill Global REIT's committed revolving credit facilities has been drawn and the above Facility is fully drawn, the aggregate level of facilities that may be affected is approximately S\$1,390.5 million (excluding interest) as at the date of this announcement.

Starhill Global REIT is a Singapore-based real estate investment trust investing primarily in real estate used for retail and office purposes, both in Singapore and overseas. Since its listing on the Mainboard of the Singapore Exchange Securities Trading Limited (the “SGX-ST”) on 20 September 2005, Starhill Global REIT has grown its initial portfolio from interests in two landmark properties on Orchard Road in Singapore to nine properties in Singapore, Australia, Malaysia, Japan and China, valued at about S\$2.8 billion.

These comprise interests in Wisma Atria and Ngee Ann City on Orchard Road in Singapore; Myer Centre Adelaide, David Jones Building and Plaza Arcade in Adelaide and Perth, Australia; The Starhill and Lot 10 Property in Kuala Lumpur, Malaysia; a property in Tokyo, Japan and a retail property in Chengdu, China. Starhill Global REIT remains focused on sourcing attractive property assets in Singapore and overseas, while driving organic growth from its existing portfolio, through proactive leasing efforts and creative asset enhancements.

Starhill Global REIT is managed by an external manager, YTL Starhill Global REIT Management Limited, of which all of its shares are indirectly held by YTL Corporation Berhad.
