**SIGNING OF SERVICE AGREEMENT WITH KL FERTILITY & GYNAECOLOGY CENTRE SDN. BHD.**

The Board of Directors of Singapore O&G Ltd. (“**SOG**”), the Company, and together with its subsidiaries, (the “**Group**”) is pleased to announce that the Company has entered into a Service Agreement (the “**Agreement**”), a commercial collaboration with KL Fertility & Gynaecology Centre Sdn. Bhd. (“**KLFGC**” or “**KL Fertility Centre**”), a wholly owned subsidiary of Monash IVF Group Ltd based in Australia, where KLFGC is to provide Assisted Reproductive Technology (“**ART**”) services to existing and new patients of SOG.

Pursuant to the terms of the Agreement, this collaboration will enable SOG to offer new and existing patients with ART services such as In-Vitro Fertilisation (“**IVF**”) and Intracytoplasmic Sperm Injection (“**ICSI**”) Procedures. ICSI is a specialised form of IVF that may be used for the treatment of severe cases of male-factor infertility.

The collaboration is for an initial term of thirty-six (36) months and is limited to the Singapore market only.

None of the Directors, substantial shareholders or controlling shareholders of the Company has any interest, directly or indirect, in the above transactions, other than through their respective interests (if any) in the Company.

The Company will make such further announcements to inform shareholders of any updates or developments as and when it may be deemed necessary or appropriate.
