ISSUANCE OF NEW ORDINARY SHARES PURSUANT TO THE VESTING OF SHARE AWARDS UNDER THE SOG PERFORMANCE SHARE PLAN

The Board of Directors of Singapore O&G Ltd. (the “**Company**” or “**SOG**”) refers to the announcement dated 8 June 2020 in relation to the grant of share awards pursuant to the SOG Performance Share Plan (the “**Awards**”).

Further to the listing and quotation notice dated 26 May 2015 received from the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) in respect of the listing and quotation of new ordinary shares to be issued pursuant to the SOG Employee Share Option Scheme and SOG Performance Share Plan, the Board wishes to announce that the Company had on 30 June 2021, allotted and issued an aggregate of 666,666 new ordinary shares in the capital of the Company (the “**New Shares**”) to the eligible employees pursuant to the vesting of one third of the Awards under the SOG Performance Share Plan.

Following the allotment and issuance of the New Shares, the number of issued and paid-up ordinary shares of the Company has increased from 477,469,668 shares to 478,136,334 shares.

The New Shares issued shall rank pari passu in all respects with the existing shares of the Company. The New Shares are expected to be listed and quoted on the Catalist Board of SGX-ST on or around 2 July 2021.

The employees have undertaken not to, directly or indirectly, offer, sell, contract to sell, realise, transfer, assign, pledge, grant any option or right to purchase, grant any security over, encumber or otherwise dispose of, all or any part of his or her shareholding in those New Shares immediately after the allotment of the New Shares for a period of twelve (12) months commencing from the date of allotment.
