LAUNCH OF SERIES 002 OF 6-MONTH COMMERCIAL PAPER ON ADDX DIGITAL SECURITIES PLATFORM

Reference is made to the Company's announcements dated 13 January 2025, 7 February 2025, 3 November 2025, 6 November 2025, 20 January 2026 and 9 February 2026 in relation to the debt issuance programme arranged by ADDX Pte. Ltd.¹ (the "Programme") (the "Announcements"). Capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements unless otherwise defined.

The Board of Directors ("**Board**") of Sanli Environmental Limited (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to announce that the Company has authorised the issuance of up to S\$5 million of unsecured commercial paper in connection with the Programme and has today, launched its second series of an unsecured 6-month commercial paper with a target issuance size of S\$3.0 million ("**6M Series 002 CP**"). The 6M Series 002 CP will have an interest rate of 5.5% per annum and will mature on a date falling on the expiry of six (6) months from the date of issuance. The 6M Series 002 CP is expected to be issued to accredited investor(s) and institutional investor(s) and to be listed on the ADDX Exchange.

The Company expects to raise between S\$3.0 million and S\$5.0 million from the 6M Series 002 CP, the amount of which may be varied at the sole and absolute discretion of the Board. The Company intends to utilise the net proceeds to be raised from the Programme to support working capital requirements for newly secured projects, including the provision of banker's guarantees, project mobilisation, and other related operational needs.

The Company will make further announcement(s) as appropriate, if and when there are material developments in respect of the issuance of the 6M Series 002 CP by the Company which warrant disclosure.
