# Applications relating to the liquidation and board changes of Alita – COR 195 of 2023

On 12 December 2023, Fergus Jockel and Paul Vincent O'Farrell (**Plaintiffs**) in their capacity as directors of Alita filed an application with the Supreme Court of Western Australia.

The Plaintiffs seek orders terminating the liquidation of Alita (the **Termination Application**) and facilitating the appointment of new directors to the board of Alita (the **Appointment Application**) before (or alternatively, in concurrence with) the termination of the liquidation. Specifically, the Plaintiffs seek leave to appoint Mr Chris Ellison, Mr Norman Ashton and Mr Boderick Sutton as additional directors of Alita

The Plaintiffs also seek leave to issue a Notice of Meeting to the shareholders of Alita (the **Meeting Application**), the proposed purpose of the Meeting Application is to receive non-binding guidance as to the shareholders' views in relation to the Termination Application and the Appointment Application.

The Meeting Application has been listed for hearing on 30 January 2024 and the Termination Application and Appointment Application have been listed for hearing on 29 February 2024.

A Notice of Meeting will only be issued after the hearing of the Meeting Application on 30 January 2024 if the Plaintiffs are successful in obtaining orders in relation to the Meeting Application.

Any interested person intending to appear in relation to any of the above applications is required to file a notice of appearance with the Supreme Court of Western Australia by 17 January 2024.

The application has been listed for a directions hearing at 9.15am on 19 January 2024 to consider whether leave to appear should be granted to any interested persons.
