Further to the announcements by the Company on 9 May 2019, 7 June 2019, 13 June 2019, 28 June 2019, 11 July 2019 and 24 July 2019 (the “**Announcements**”), the Company wishes to announce that 168,247,125 Rights Shares and 168,247,125 Warrants are expected to be allotted and issued on 29 July 2019.

The Rights Shares and Warrants are expected to be credited to the Securities Accounts of successful Entitled Depositors on 29 July 2019. The certificates representing the number of Rights Shares and Warrants validly subscribed for by Entitled Scripholders are expected to be despatched on 29 July 2019.

All 168,247,125 Rights Shares and 168,247,125 Warrants are expected to be listed and quoted on the Main Board of the SGX-ST on 29 July 2019 and 30 July 2019 respectively. Trading of the Rights Shares and the Warrants is expected to commence with effect from 9.00 a.m. on 29 July 2019 and 30 July 2019 respectively.
