## TEE INTERNATIONAL AWARDED S\$130M WORTH OF NEW CONTRACTS

- To provide A&A works for Centrepoint Shopping Centre in Singapore
- Appointed as main contractor for mixed-used development in Malaysia

**SINGAPORE**, 6 May 2015 – Mainboard-listed **TEE International Limited** (特毅国际有限公司) (“**TEE**”) and together with its subsidiaries and associated companies (“**TEE Group**”), a regional Engineering, Infrastructure and Real Estate group, was awarded two contracts worth approximately S\$130 million, thereby crossing the half a billion dollar mark with a total outstanding order book of about S\$540 million as of date.

The first contract was awarded by FCL Property Investments Pte Ltd (a wholly-owned subsidiary of Frasers Centrepoint Limited) to provide Addition and Alteration (“A&A”) works to Centrepoint Shopping Centre located at Orchard Road. The A&A contract, which is worth approximately S\$30 million, is the second project that TEE has been given the opportunity to carry out works for Frasers Centrepoint Limited (“FCL”) in recent months.

Earlier in April this year, TEE was also appointed by FC Commercial Trustee to provide engineering works for Frasers Tower, a 38-storey Premium Grade A office tower linked with a retail podium, located at Cecil Street in Singapore’s Central Business District.

Mr Eric Phua, Managing Director of TEE’s Engineering business said: ***“We are pleased to be appointed to carry out A&A works for Centrepoint Shopping Centre, an iconic mall in Orchard. This contract was awarded shortly after signing the LOI to provide engineering works for Frasers Tower, another prestigious project by FCL. Being involved in two***

***consecutive projects from FCL further attest our engineering capabilities, and our established track record where new clients become repeat clients.”***

The second contract that is worth RM266,750,000 (approximately S\$100 million), was awarded by TEE Resources Sdn Bhd (“TEE Resources”), an indirect wholly-owned subsidiary of TEE Land Limited, to PBT Engineering Sdn Bhd (“PBT Engineering”), an indirect wholly-owned subsidiary of TEE. PBT Engineering was appointed as the main contractor for the execution and completion of TEE Resources’ mixed-used development project, Third Avenue, in Cyberjaya, Malaysia.
