Reference is made to the Issuer's announcement dated 31 May 2023 (the “**31 May Announcement**”) and the announcement dated 12 June 2023 (the “**12 June Announcement**”) in relation to the Tender Offer made by the Issuer in respect of the Notes. Unless otherwise defined herein, all capitalized terms used in this announcement shall have the meanings given to them in the 31 May Announcement and the 12 June Announcement.

The Issuer wishes to confirm and announce that the conditions set forth in the Tender Offer Memorandum have been satisfied and the settlement of the Tender Offer was completed on 16 June 2023. The Issuer has also authorised Citicorp International Limited, to take such steps as are required to cancel the purchased Notes on its behalf, such cancellation to take effect for value on 16 June 2023. Following the completion of the Tender Offer and the cancellation of the purchased Notes, the outstanding aggregate principal amount of the Notes will be U.S.\$138,057,000.
