We refer to all the announcements made earlier and the latest dated 28 February 2019 in relation to the above legal proceedings ("Announcements"). Unless otherwise defined, the terms used herein shall have the same meaning as those defined in the Announcements.

The Company wishes to announce the following updates in relation to the Singapore OS:

- As announced previously, the Company and Top Care obtained an *ex parte* Order of Court dated 2 July 2018 from the High Court of the Republic of Singapore ("the Court") which prevented Adventa Capital Pte Ltd ("Adventa Capital") from disposing of or dealing with or diminishing the value of its assets whether they are in or outside of Singapore, save for its assets in Malaysia ("the Mareva Order") up to the value of RM714,862,759.
- Adventa Capital filed an application to set aside the Mareva Order, which was heard by the Court from 14 to 16 May 2019.

- The Court gave its decision on 10 June 2019, setting aside the Mareva Order but granting an Erinford injunction up to the value of RM714,862,759 on the same terms as the Mareva Order, provided that the Company and Top Care make an application for a Mareva injunction to the arbitral tribunal (in SIAC Arbitration No. 171 of 2018) within two weeks, upon which the Erinford injunction will remain in force until there is a determination by the arbitral tribunal.
